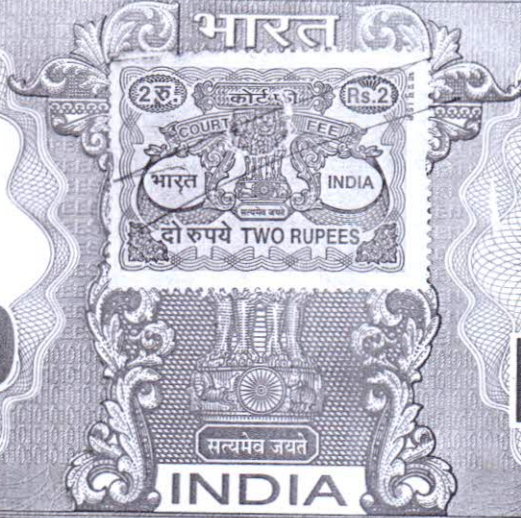

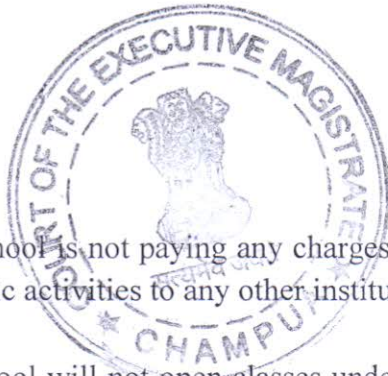
- That Kerala Welfare and Educational Development Trust (under section 25) is a registered Trust under the Societies Registration Act 1860.
